Please be advised that Cabinet has granted approval for the under mentioned products to be VAT Zero-rated with effect from November 3<sup>rd</sup>, 2025:

- 1. Other chicken parts
- 2. Processed cheddar cheese
- 3. Canned tuna
- 4. Canned sardines
- 5. Chicken sausages
- 6. Cereals
- 7. Lentils
- 8. Categories of health drinks
- 9. Adult diapers

NB. Chicken backs, necks and wings are already zero-rated. Therefore, the other chicken parts (poultry cuts) that are zero-rated include thighs, legs, leg quarters, breast, drumsticks, and feet.

The categories of health drinks refer to liquid nutritional supplements containing ingredients such as protein, vitamins and minerals to supplement the diet. These include but are not limited to Ensure, Supligen, Boost, Pediasure, Nutriment and Glucerna.
