## ACT NO. 25 OF 2008 I ASSENT

AN ACT to amend the Customs Duties Act.

[16th December, 2008]

**BE IT ENACTED** by the Queen's Most Excellent Majesty, by and with the advice and consent of the House of Assembly of Saint Vincent and the Grenadines and by the authority of the same as follows:

1. (1) This Act may be cited as the Customs Duties (Amendment)

Short title and commencement

- (2) This Act comes into force on the 1st day of January 2009.
- 2. Section 3B of the Customs Duties Act is amended by deleting from the column headed "Heading No.", the figures appearing opposite the goods and surcharge listed in the column headed "Description of goods" and "Vehicle surcharge, vehicle over 4 years old" and inserting the figures appearing hereto under the column headed "Heading No.":
